The Foundation collaborated with 34 not-for-profit and for-profit organizations in the past year. More than 500 individuals annually support the mission of Conservation Foundation. Cumulatively over the past twelve years, revenues totaled more than \$40,000,000 coming from contributions, grants, and other program fees such as contract work with Sarasota County's environmentally sensitive land acquisitions program.
