Conservation Foundation of the Gulf Coast has protected 33 properties, nearly 9,725 acres, in thirteen years, creating preserves and conservation areas across four counties. The Foundation collaborated with 36 not-for-profit and for-profit organizations in the past year. More than 500 individuals annually support the mission of Conservation Foundation. Cumulatively over the past thirteen years, revenues totaled more than \$42,800,000 coming from contributions, grants, and other program fees such as contract work with Sarasota County's environmentally sensitive land acquisitions program.
